To the Local 591 Membership:

Our Membership has called for better quality and lower cost voluntary insurance options for quite some time, including Long & Short Term Disability, Life Insurance products, etc. While not only important for them, this effort is especially important for our members who already have voluntary Union Insurance benefits. You can confirm you have voluntary Union insurance by looking at the bottom of your paycheck under the “*NET EARNINGS DISTRIBUTIONS*” section, if you see “THE BANCORP.COM” as an account type then you have some of these voluntary Union insurance benefits.

Your Local is exploring a number of insurance options. We discovered that insurance brokers cannot provide useful quotes without more detailed demographic information which we normally have. In order to get the best benefits and rates, and the most accurate quotes possible from insurance carriers, we need additional details from you which we do not normally ask for. To do this, Local 591 is conducting a member information update campaign from January 31<sup>st</sup> through February 14<sup>th</sup>. This information will not be retained within our normal Local 591 Member contact information system, and the information will not be used for any purpose other than seeking better voluntary insurance benefits for our members.

There are two primary reasons why updated member information is important.

- Accurate member information assists TWU Local 591 to better negotiate Member benefits, both through enhanced insurance benefits and also better pricing
- Accurate member information assists TWU Local 591 with accurate and up to date information for communications to our members and assisting with life events.

To ensure member information is accurate, we are providing you with a secure online form to update your information.
